Council of the City of Wheeling met in Council Chambers, City-County Building, on the above date, with Mayor Glenn Elliott presiding.

Mr. Thalman moved, seconded by Mr. Thorngate, that the minutes of the September 3, 2019 meeting be approved as received. Motion carried.

PUBLIC HEARING

Mr. Palmer, seconded by Mr. Thorngate to suspend the regular order of business to conduct three public hearings on the following: Community Development Block Grant (CDBG) and Home Investment Partnership Program (HOME) FY 2018 Performance Hearing, Public hearing will be held to amend and readopt article 1735 of the International Energy Conservation Code, Transfer 1508 Market St Property to the State of West Virginia Public Land Corporation. No one signed up to speak on either topic. Mr. Palmer, seconded by Mr. Thorngate to resume the regular order of business.

PUBLIC SAFETY COMMITTEE REPORT September 12, 2019 The Public Safety Committee of

Wheeling City Council met on the above date at 12:00 p.m., in City Council Chambers. Committee Members present: Chair Dave Palmer and Member Melinda Koslik. Vice-Chair Ken Imer Absent. Others present: Councilors Thalman and Scatterday; City Manager Robert Herron, City Solicitor Rose Humway-Warmuth, City Clerk Brenda J. Delbert, and media.

The following matters were discussed: Discussion on Police Department Reduction in Sergeant Positions

Mr. Palmer invites Police Chief Shawn Schwertfeger to present his request in reduction of Sergeant Positions. Chief Schwertfeger states there are currently 20 Sergeant Positions almost 1/3 of the department. He strongly believes this is too many for a department of our size. The Sergeant is an extremely important position, they are the first line supervisor; there are currently four who do not supervise anyone. Chief Schwertfeger is recommending 15 Sergeant positions assigned to the following: 10 for patrol, 1 investigator, 1 drug task force, 1 staff/special operations/traffic, 1 office of professional standards, 1 public resource officer. There will be no immediate cuts but will happen over time. The estimated financial savings is \$27,000. Chief Schwertfeger is recommending the extra 5 positions to be placed into the PFC rank. Mr. Herron explains this will go back to the way it was prior to May 2010 when previous Chief requested the increase from 15 to 20. Ms. Koslik moves, seconded by Mr. Palmer to accept to forward the proposal to Council.

Discussion on Fire False Alarm Ordinance Mr. Palmer invites Fire Chief Larry Helms to present his request. Chief Helms clarifies this only applies to false medical, EMS calls. The premise is to implement same as WPD false alarm program. Chief Helms explains most false calls come from “pull calls” when the string is pulled EMS is called. When EMS responds the crew cannot identify what apartment made the call; 76 false calls were at one location and only 17 were able to be traced to the original location. Property owner will be held accountable if the apartment location cannot be identified. Chief Helms believes a third-party involvement is unnecessary for enforcement and it should be handled through Municipal Court. Ms. Koslik moves, seconded by Mr. Palmer to accept to forward the proposal to Council.

There being no further business to come before the Committee, Ms. Koslik moved, seconded by Mr. Palmer, to adjourn. Motion carried. Time: 12:34 p.m.

City Manager Robert Herron asks Council for two reads on items 9/1 and 9/2 citing timeliness issues. Mr. Herron gives a brief overview of August Financials, and also announces Wheeling Fire Department has received a 700k grant. There are matching stipulations and grant is only good for three years. Mr. Herron says the time is perfect and matches well with staggering personal and overtime projects.
