Betsy S. suggested that the History and Literature committee compile how they would like to proceed and then submit that information to Phyllis Sigal.

• Ron S. has been in touch with performers in the area about potentially recording monologues/short performances/songs that can be posted to our Facebook page. There are 4 artists already lined up: 1 musician, 2 theater performers and 1 singer.

New Business

• Virtual Arts Project - Mindi Y. has an idea to do a virtual public arts mural tour of Wheeling and then post it to our Facebook page. and performances. Mindi will start a list on Google Drive that can be divided out among the commission members.
