Mayor Elliott and Mr. Thalman agree the program has exceeded expectations and would like to have funding in place to cover those who have applied. Minimum of \$2,000,000 to cover the 433 eligible. Mr. Herron indicated there are safeguards in place and there are no exceptions regarding inspections, permits, or B&O etc. Mr. Thalman, seconded by Mr. Thorngate, to increase the allocated amount to fund those who are eligible and have applied. All in favor. Motion carried.

City County Building Improvements Projects:

Ohio County Commission is proposing an eleven million dollar building upgrade. Including heating, cooling, ventilation, roof, windows, lights suppression system, and electrical upgrades. According to the lease the city is financially responsible for 40% of work in building. County is seeking proposals for bond. Current rent is \$192,464. Rent will increase and amount would be contingent if 15- or 20-year lease. No action required today as matter will come back to City Council.

October 2022 Financial Statement:

Mr. Herron reviewed the financial statement for October 2022. Conferring to page 14A cash balance is 4.3 million, this is up \$500,000 in comparison to last year. There has been a significant bounced back compared to last month. Mr. Herron indicated expenses on track while B&O and property taxes have recovered. Board of Education has made payment for school resources officers. Sales tax are also ahead. Including but not limited to the following: \$5,000 grant with 20% match (\$1,000), owner-occupied, exterior repairs done in a manner generally consistent with the National Park Service Historic Preservation Standards and Guidelines, daylight down spouts (if feasible without significant construction), pre-1940 homes, eligible homes must have an assessed market value below \$350k market value by the Ohio County Assessor, applicants cannot have received funding under the Homeowner Assistance Repair Program or the Façade Improvement Program, and possible involvement from the Historic Landmarks Commission.
