### May 2023 Financial Statement:

Mr. Herron presented the May 2023 Financial Statement and progress of end of Fiscal Year reports. No issues or questions regarding the statement from the committee. Mr. Thalman, seconded by Mr. Thorngate, move to accept the Financial Statement as presented and forward to Council. All in favor. Motion carried.

**ARPA Requests:** Mr. Palmer introduced the following list of ARPA funding requests. The following allocations were requested for particular matters however no motions or seconds were made to move to council on the following, Centre Market, Mobile Stage, Ambulance.

Wesbanco Splash Pad, Warwood Splash Pad, Engineering Splash Pads-Mr. Palmer introduced the funding requests for the engineering services and splash pad construction costs, Wesbanco Splash Pad for \$348,500, Warwood Splash Pad \$359,622 and Engineering Services with CT consultants for \$66,000. A lengthy discussion ensued regarding specifics of splash pads, operations and maintenance. These requests were previously moved to City Council, however Mr. Thalman motioned, seconded by Mr. Thorngate to approve move to Council. Motion Carried. Request for Victorian Home Program, discussion of the funding source for the Victorian Home Program which was \$500,000 was previously committed by council. Request for Trucks and Loader in the amount of \$ 525,000 was discussed. Mr. Palmer stated the trucks are much needed upgrades for our operations department. Mr. Herron confirmed vehicles are in need of repairs, when new vehicles are purchased, older ones will be swapped out and auctioned. Mr. Thalman, seconded by Mr. Thorngate motioned to send to Council for approval. Motion carried. Request for YWCA request from Ms. Lori Jones with the YWCA for \$250,000 was presented. Ms. Jones explained that the money is needed to cover costs for building improvements. Mr. Thalman motioned, seconded by Mr. Thorngate to approve sending to Council. Motion carried. Request for Plaza Playground in the amount of \$201,071 for the Market Street Playground structure to be built behind the Vineyard Church located behind their building on 1000 Main Street. The playground is necessary as dictated by state regulations for Childcare services. Pastor Chris Figaretti from the Vineyard Church was present to answer questions. A lengthy discussion ensued; all agreed child care facilities are a much-needed resource within our city. Mr. Thalman motioned; Mr. Thorngate seconded to send the request for the playground at Market Plaza to City Council. Motion carried.
