REMARKS FROM MEMBERS OF COUNCIL

Mr. Palmer remarked on the Monument Bridge closure in Elm Grove and the passing of the new traffic rule regarding a right turn only on the bottom of Junior Avenue. Mr. Palmer also shared heartfelt appreciation to Councilman Seidler, for his dedication and leadership helping the community, during the recent flooding. Mr. Sklavounakis echoed Mr. Palmer's remarks thanking Mr. Seidler for his leadership and also thanking the House of Carpenter for their continued resources and assistance. Mr. Sklavounakis thanked his fellow councilors for passing the Valley View storm and sewer project ordinance and is excited for that work to be completed. Ms. Ketchum recognized Wheeling Park High School Students for their help removing flood waste and litter, Ms. Ketchum thanked various agencies as well as City Manager for their work on the managed homeless encampment. Also noted the Ohio County Solid Waste Authority's Earth Day celebration on April 20th from 1-5pm at Wheeling University.

Mr. Seidler expressed gratitude to House of the Carpenter for their unwavering help during the flood and in supplying resources for residents to clean up. Mr. Seidler also thanked all city departments, specifically police, fire, sanitation, operations, administration, dispatchers and others for their help to keep our community safe and recover from the flooding, to show appreciation Councilman Seidler announced a luncheon to be held Friday honoring all the city employees. Mr. Seidler asked City Solicitor and Manager to look at amending trash ordinances in regards to scavenging of junk and trash, also asked for some way to credit or reduce costs associated with water and sewage bills for island residents. Lastly, he asked for the former Wheeling Inn building to be secured by code enforcement as it has been left to the elements and is victim to squatting and vandalism.

REPORT OF COMMITTEES

REPORT OF CITY MANAGER

City Manager Herron noted crews will mobilize around May 27th for painting of the Heritage Trail Bride, the contractor is from North Carolina and the project is expected to last 30-40 days, expect some travel restrictions. Pulaski field/playground improvements will be complete within in the next week, demolition of the Clator, Elm Terrace and 36th Street Playgrounds as begun. Landscaping for the Streetscape project has begun on Main Street. Mr. Herron stated the storm sewer project between Market and Main streets is still on track with paving of Main Street to be complete by end of June. Ms. Ketchum asked City Manager for time line of 22nd Street Sewer project, roughly 30-45 days until completion. Mr. Thalman asked for details regarding the sidewalk assistance program, Mr. Herron stated applicants will soon be able to start applying for loans most likely through Wesbanco Bank.
