The Development Committee of Wheeling City Council met on Tuesday, August 15, 2017 at 4:30 p.m. in Council Chambers. Committee members present: Mayor Glenn Elliott, Vice Chair Wendy Scatterday, and Member Chad Thalman. Property Transfers Project Status Updates:

The following property owners gave updates on the status of their projects:

Andrew Yetter - 1517 Wood Street and 167 - 16th Street - Assistant ECD Director Tom Connelly explained that this property was transferred August 2016 with an 18 month turnaround time. Mr. Yetter said that they started with some improvements, such as painting, windows, gutters, fascia, etc., just the last couple of months as he was busy with projects elsewhere. He said the reason for the delay was that they were waiting for an asbestos report on the back portion of the building. He said that he just received the report today and will have to deal with some asbestos removal. Mr. Yetter said that he is about 30% into the project. He indicated that he recently received a letter of intent from someone interested in putting in a brewery/restaurant at this location and he hopes to have this completed by June of 2018. Mr. Yetter said that they still have some landscaping to do with the parking lot and indicated that the parking plan with Enterprise is working well for both of them. In response to a question from Mr. Thalman, Mr. Yetter indicated that Enterprise is renting 8 or 10 spots in the parking lot out of the 26 or so that

are available but are currently using more; however, he said that when the restaurant opens, they will have specific parking for each. Mayor Elliott asked Mr. Yetter if the letter of intent was signed and Mr. Yetter indicated that it had been.

In response to a question from Mayor Elliott as to when they would expect concrete plans for the restaurant, Mr. Yetter said that he would expect plans to be developed in the next three to six weeks.

Sarel Venter and Rebekah Karelis - 1069 Main Street - This property was transferred in June, 2016. Mr. Venter reported on the progress of his project. He said that their initial project was rehabilitation of the back portion and restoration of the first floor; however, he indicated that he had run into some unexpected structural problems with the entire building but is working through them. As far as the time frame as to when it will be finished, he said that it will probably be longer than initially thought but will still be done in the time frame they were originally given.

Wilfred Spencer -126 15th St. - This property was transferred in October, 2016. Mr. Spencer updated the committee on the progress of his project. As with the other projects, unforeseen structural and roof issues have slowed the project down somewhat. He hopes to complete the project in the next three months or so. The project will be a single-family, two-bedroom home.

Request for Redevelopment Area at 2085 National Road by Scott Peklinsky, Gumby's, LLC.

Mr. Peklinsky spoke on behalf of Gumby's, LLC. Their request is to operate this location as one of their Geno's café. Since it is within 1000 feet of another video lottery location, the request for redevelopment is needed. Mr. Peklinsky indicated that they will be required to have a liquor license, however, they will only serve beer at this location. In response to a question from the committee, City Manager Robert Herron said that the administration recommends approval of this request. Following a short discussion, Mr. Thalman moved, seconded by Ms. Scatterday, to approve this request and forward it to Council. Motion carried.

Bob Ingram, Bill Clatterbuck, Joseph McGinley, Bob Kennen, Beth Hinebaugh, Alex Coogan, Bill Valput, and Paul McMann, all spoke in opposition to the proposed registration program, believing that it will be an undue burden on landlords and that it would be a "bureaucratic mess" to deal with. Several of the landlords who spoke said that the information that is requested from this program is already available in the Ohio County Tax Offices; however, Mr. Palmer responded that it is not available if they do not pay their taxes.

Susan Hagan spoke in favor of the proposed program, as well as Reverend Ralph Dunkin, who read a letter from the Wheeling Human Rights Commission in support of this proposed program.

Ray Carney, a resident of North Wheeling, had no problem with the registration other than the fact that he believes there are methods already in place to address these issues. He also pointed out that the "guidelines" contained in the proposed registration are rather "vague."

Following some discussion, Mr. Palmer indicated that the Committee would take into account the comments made by those speaking this evening before any definitive action is taken. He also said that it would require final approval from the entire City Council. Mr. Palmer thanked everyone for coming out and offering their input.
