

WHEELING TRAFFIC COMMISSION – July 12, 2018

The Wheeling Traffic Commission met for its monthly business meeting on the above date in City Council Chambers with Acting Chair Duvall presiding. The meeting was called to order at 2:13 p.m.

APPROVAL OF MINUTES

Member Duffy moved, seconded by Member King, to approve the minutes of the June 12, 2018 meeting as presented. Motion carried.

NEW BUSINESS

Request by Paul Lee, 454 N. Wabash St Apt 3, for handicapped parking space in front of residence. Mr. Lee is present and speaks on behalf of his request. Member Duffy, seconded by Member King to recommend the following traffic rule to Council:

TRAFFIC RULE: 4678: TO ESTABLISH A HANDICAPPED PARKING ZONE IN THE EAST SIDE OF N. WABASH ST DIRECTLY IN FRONT OF 454 N. WABASH STREET IN THE CITY OF WHEELING, AND EXTENDING ON N. WABASH STREET FOR A DISTANCE OF 22 FEET

Request by Anthony Krupinski, 4527 Wetzel St, for handicapped parking space in front of residence. Mr. and Mrs. Krupinski are present. Mrs. Krupinski speaks on her husband's behalf. She explains car is typically parked in garage outback but husband cannot walk down the back steps. She will drive around front to pick him up. Member King, seconded by Member Duffy to deny the request because space would not be utilized often. The recommendation was to allow one-hour parking directly in front of residence. Member Duffy, seconded by Member King to recommend the following traffic rule to Council:

TRAFFIC RULE 4679 TO ESTABLISH A ONE HOUR PARKING ZONE ON THE WEST SIDE OF WETZEL STREET DIRECTLY ON FRONT OF 4527 WETZEL ST, IN THE CITY OF WHEELING, AND EXTENDING ON WETZEL STREET FOR A DISTANCE OF 22 FEET.*

*After the conclusion of the meeting Mrs. Krupinski notified the City Clerk she would not like the signs installed. Thus, this traffic rule was never forwarded to City Council.

Request by Elizabeth Starkey, 415 Jones St, for handicapped parking space in front of residence. Ms. Starkey is present and speaks on behalf of his request. Member King, seconded by Member Duffy to recommend the following traffic rule to Council:

TRAFFIC RULE 4680: TO ESTABLISH A HANDICAPPED PARKING ZONE IN THE EAST SIDE OF JONES STREET DIRECTLY IN FRONT OF 415 JONES STREET, IN THE CITY OF WHEELING, AND EXTENDING ON JONES STREET FOR A DISTANCE OF 22 FEET

Request by Elaine Pavlic. 110 N 16th St, right lane of Osage Lane to be made no parking zone. No one was present for this request however, there were two written objections received from neighbors. Objections were forwarded to the Traffic Commission. After an onsite evaluation Member Duffy, seconded by Member King to recommend the following traffic rule to Council:

TRAFFIC RULE 4681: TO ESTABLISH A NO PARKING ZONE ON THE SOUTH SIDE OF OSAGE LANE DIRECTLY ACROSS FROM THE GARAGE BEHIND 110 N. 16TH STREET, IN THE CITY OF WHEELING, AND EXTENDING ON OSAGE LANE FOR A DISTANCE OF 15 FEET

Request by Tim Birch, Operations Superintendent, for a small no parking zone in alley directly across from Windsor Manor and add meter parking. There are cars parked there daily, he feels needs to be a metered zone but allow room for maintenance vehicles to enter and exit. metered zone on Lane 7 to be no parking from the hours of 3am to 7am to allow sanitation trucks to pass. Member King, seconded by Member Duffy to recommend the following traffic rule (s) to Council:

TRAFFIC RULE 4682: TO ESTABLISH A NO PARKING ZONE ON THE WEST SIDE OF WATER STREET BEGINNING AT THE SOUTHWEST CORNER OF 11TH STREET AND WATER STREET, IN THE CITY OF WHEELING, AND EXTENDING IN AN SOUTHERLY DIRECTION ON WATER STREET TO 12TH STREET

TRAFFIC RULE 4683: TO ESTABLISH A 2 HR PARKING METER ZONE BETWEEN THE HOURS OF 8 AM AND 5 PM, MONDAY THROUGH FRIDAY, ON THE EAST SIDE OF WATER STREET BEGINNING 30 FEET SOUTH OF THE SOUTHEAST CORNER OF 11TH STREET AND WATER STREET, IN THE CITY OF WHEELING, AND EXTENDING IN A SOUTHERNLY DIRECTION ON WATER STREET TO THE WINDSOR ALLEY

There being no further business to come before the Commission, Member King, seconded by Member Duffy, to adjourn. Motion carried. Time: 2:46 PM.
