# REMARKS FROM MEMBERS OF COUNCIL

Mr. Seidler thanked Panhandle Cleaning and Restoration for their efforts to encourage dining and support of local restaurants downtown with a punch card program that enters individuals in a chance to win \$1,000. Ms. Ketchum asked for support to pause or delay prohibited camping ordinance until a managed camp is complete, and asked for guidance on how and where individuals experiencing homelessness can store their belongings.

Mr. Palmer also thanked Panhandle Cleaning and Restoration for their efforts and encouraged other businesses to show support, and create other incentives to get more residents downtown.

#### REPORT OF CITY MANAGER

Mr. Herron stated the WVU Hospital's demolition of the OVMC structures starting next week with the former Northwood Health Building first. The city has received its first Opioid Settlement in the amount of \$727,000, this is the first of two payments the city will receive. The use of these funds criteria is strict and must be met, once reviewed recommendations will be given for use of the funds and must be passed by a resolution. Mr. Herron introduced Stephanie Hockenberry she is the new Growth and Retention manager for Ohio County, her position was created by numerous agencies, the city being one. Mr. Herron noted officer discretion is being used for the cleaning up of homeless encampments, the police department will try to assist these individuals to get them to local agencies to help find placement. Ms. Ketchum asked for an update on Pulaski Park improvements, Mr. Herron stated they are paused due to winter weather but are under contract and will continue in the spring.
