Mr. Thalman asked City Manager for an update on city sidewalk and homeowner sidewalk program, Mr. Herron noted sidewalks are being reviewed by Precision and will be paid for out of the regular RCIP account, and working on a loan program for homeowner sidewalks. Ms. Ketchum asked for information on Suspension Bridge, City manager had no new information to report.
