Council of the City of Wheeling met in Council Chambers, City-County Building on the above date with Mayor Andy McKenzie presiding.

Mr. Fahey moved, seconded by Mr. Henry, that the minutes of the March 1, 2016 meeting be approved as received. Motion carried.

"PUBLIC HEARING - REPROGRAMMING FY 2014 CDBG FUNDS - VINE STREET SLIP REPAIR PROJECT"

Mr. Fahey moved, seconded by Mr. Henry, to suspend the regular order of business to conduct a public hearing. Motion carried.

City Manager Robert Herron explained that the City proposes to repair the slippage on Vine Street in East Wheeling with a piling and lagging wall. It is estimated the project will cost \$80,000.00. CDBG Funds in the amount of \$15,285.00 would be reprogrammed from FY 2014 Curbs and Sidewalks and an additional amount of \$64,715.00 from FY 2014 Contingencies for a total of \$80,000.00. A like amount would be reprogrammed to a new line item within FY 2014 to be called the Vine Street Slip Repair Project.

There was no one present to speak at the public hearing, therefore a motion by Mr. Fahey, seconded by Mr. Henry, to conclude the public hearing and resume the regular order of business was made. Motion carried.

MAYOR'S REPORT

Mayor McKenzie presented a proclamation to Economic and Community Development Director Nancy Prager proclaiming the month of April as Fair Housing Month. He also presented a proclamation to Margaret Brennan of the Wheeling Historical Society proclaiming March 11, 2016 as the City of Wheeling's 180th Birthday (of its incorporation as a City).

As Mr. & Mrs. Patrick Cassidy were not able to attend the State of the City luncheon to receive their plaque in recognition of their renovations to their historic "First Capital" building, he presented the plaque to Mr. Cassidy this evening.

DEVELOPMENT COMMITTEE REPORT - MARCH 8, 2016

The Development Committee of Wheeling City Council met on Tuesday, March 8, 2016 at 3:30

p.m. in Council Chambers. Committee members present: Mayor Andy McKenzie, Member Gene Fahey. Others present: Councilors Imer and Miller; City Manager Robert Herron, City Solicitor Rosemary Humway-Warmuth, ECD Director Nancy Prager, Assistant ECD Director Tom Connelly, City Clerk Janice Jones.

Proposals for City-Owned Properties

City Manager Robert Herron explained that these proposals were for City-owned properties formerly known as the Keg and Kraut and adjacent properties located at 163-165, 167 16th St., 1517 Wood St. And vacant lot; and City-owned property formerly known as Tom's Pizza located at 1069 Main St. Two proposals were received for each of the addresses. Following a discussion, which included an explanation of the scope of work from three of the four developers on their projects, Mr. Fahey moved, seconded by Mayor McKenzie to review the proposals and further discuss them at a future Development Committee meeting which will be scheduled before the end of March if at all possible.

REPORT OF CITY MANAGER

City Manager Robert Herron said that the CDBG Public Services Requests, along with the Proposed CDBG Budget were distributed to Council this evening. Relevant to the proposed CDBG paving schedule, permission will be requested from HUD to do an income survey of the area around Alberta, Dorothy and Laurel Avenues to see if they qualify as a low to moderate income area so that CDBG funds could be used for paving the streets that are in pretty bad condition.

Mrs. Delbrugge asked the City Manager about the water issue on Hildreth Avenue and the Warwood Tennis Courts. Mr. Herron said that the Hildreth Water Line Project is currently under design and should be done this year. As for the tennis courts, Edgco has been authorized to do the demolition and the tennis courts have been designed and will go out to bid shortly.

Mr. Miller said that all of Council has received notification from the WVDOH about the rehabilitation of National Road from Bethany Pike to Park View Lane. In response to Mr. Miller's question about the time frame, Mr. Herron said that the District Engineer has indicated that this would be done in this year's construction season and that it would entail rotomilling and paving National Road.

Mr. Herron updated Council on the Kruger Street project and the lighting project that is occurring in Elm Grove and the Zane Street Project that is occurring on Wheeling Island.

Mr. Herron respectfully requested an executive session to discuss a matter of personnel at the end of the meeting.
