Mrs. Delbrugge thanked everyone who worked on the Garden Park Pool House. She said that they did a fantastic job. She also reiterated Mr. Atkinson's remarks about all the city workers who assisted with the storm clean up last week. Little Ceasar's and McDonald's should also be commended for feeding the workers.

Mr. Imer updated the Council on the progress of the Parking Committee's review of various parking garages and parking lots and offered recommendations from the parking committee to Council.

REPORT OF CITY MANAGER

City Manager Robert Herron reported that the City's portion of the Auction that was held last week-end at the Clator Operations Center was approximately \$71,000.00.

Mr. Herron announced that the new Finance Director, Seth McIntyre, will begin working on May 23^{rd} .

Mayor McKenzie asked if Mr. Herron was still considering a 3% pay raise for employees as was discussed during the budget planning session. Mr. Herron said that he believes there is sufficient funding that would allow us to do this if Council so chooses.
