REMARKS FROM MEMBERS OF COUNCIL

Mr. Thalman also welcomed Troop 5 to tonight's meeting and commented that he graduated from St. Michael's also. He reported that the City, along with "Grow Wheeling Pride" installed a gazebo at Garden Park and this Saturday, beginning at 9:00 a.m., the committee on volunteerism, Wheel Help, will be painting the fence around Garden Park.

Mr. Thorngate announced that Ward Five will be conducting Ward Five/Crime Watch meetings on the first Thursdays of the month at 7:00 at Christ United Methodist Church on National Road. The first meeting is scheduled for November 3rd.

Mr. Palmer commented that, due to a prior commitment at work, he will have to leave prior to "Those Wishing to Be Heard." He announced that the Elm Grove Crime Watch meeting will be tomorrow evening at 7:00 p.m. at the Elm Grove Civics. Mr. Palmer asked that the City Manager and City Solicitor look at crafting a "Fireworks" Ordinance, similar to the City of Fairmont's, limiting the discharge of fireworks to a certain number of days. Relevant to a newspaper article following the Affordable Housing Ad Hoc Committee meeting, Mr. Palmer commented that he was very upset to read the remarks that were made by the committee about the City's Inspection Department. He believes that they were untrue and unfounded.

Ms. Scatterday concurred with Mr. Palmer's remarks about the Inspection Department. She said that often the people that complain are not knowledgeable enough about the building and structural requirements and probably should seek professional assistance. Relevant to the drug epidemic in the area, she assured the public that we are continually working on this problem. She expressed her appreciation to the Police and Fire Departments who are also working aggressively on this problem.

Ms. Scatterday reported on the Public Works Committee meeting that occurred last week. She said that our consultant reviewed in detail, including the historical development of the sewer system, a proposed third phase of the Long Term Control Plan which is needed to get the City in compliance with State and Federal environmental regulations. The Committee Report will be included on the October 4, 2016 agenda.
