Mayor Elliott thanked Ms. Scatterday and all the volunteers for their efforts.

Mr. Thalman reported that the tennis courts are under construction and are coming along smoothly. He also thanked the Public Works Director Russell Jebbia and the Operations Department for repairing the slip on Warwood Terrace.

Mr. Thalman briefly reviewed discussion that took place at the Ohio County Board of Health meeting today. He also updated that public about what occurred at the Finance Committee meeting prior to this evening's meeting. He noted that the Finance Committee agreed to give \$10,000.00 to \$15.000.00 to Centre Market for Christmas Lights. A Finance Committee Report will be presented at the next meeting.

## REPORT OF CITY MANAGER
