

**WHEELING TRAFFIC COMMISSION**  
**October 11, 2018**

The Wheeling Traffic Commission met for its monthly business meeting on the above date in City Council Chambers with Chair Duvall presiding. The meeting was called to order at 2:10 p.m.

APPROVAL OF MINUTES

Member Adams moved, seconded by Member Duffy, to approve the minutes of the September 13, 2018 meeting as presented. Motion carried.

OLD BUSINESS

Woodsdale School Car Rider Dismissal Guide (Tabled 8/16/18 and 9/13/18) Principal Minch was present to give updated report. Ms. Minch has been working with Mr. Byrd, Cobblestone Condominiums, and reached an agreement. A new map and site plan were approved by all. Mr. Byrd was also in attendance, he agrees there has been a lot of communication and no longer opposes the proposed dismissal procedures. Member Duffy commends the two for working together to reach an agreement. Tim Birch clarifies the no parking rules are school days only, and the previous restricted parking on Maple Ave is no longer necessary under the new provisions. Member Duffy, seconded by Member Adams to recommend the following traffic rule to Council:

TRAFFIC RULE 4690: TO ESTABLISH A NO PARKING ZONE ON THE NORTH AND SOUTH SIDE OF POPLAR AVE BEGINNING AT CORNER OF BETHANY POLE AND POPLAR AVE, IN THE CITY OF WHEELING, AND EXTENDING IN AN EASTERLY DIRECTION ON POPLAR AVENUE TO THE INTERSECTION WITH THE UNNAMED ALLEY LOCATED BEHIND WOODSDALE SCHOOL

TRAFFIC RULE 4691: TO ESTABLISH UNRESTRICTED PARKING ON THE NORTH SIDE OF MAPLE AVENUE BEGINNING AT THE NORTHWEST CORNER OF BETHANY PIKE AND MAPLE AVENUE, IN THE CITY OF WHEELING, AND EXTENDING IN AN EASTERLY DIRECTION ON MAPLE AVENUE TO THE UNNAMED ALLEY BEHIND WOODSDALE SCHOOL

Request by Councilor Ty Thorngate for stop sign on Euclid Ave at the intersection of Euclid and McClain. After a traffic study was completed the average speed of vehicles on Euclid Ave was 24.5 MPH and McClain Ave was 24.3 MPH. According to the study vehicles are obeying speed limits. Member Duffy moved, seconded by member Adams to deny the request for a stop sign. Motion carried.

NEW BUSINESS:

Request by James P Sacco, 18 Vermont St, for handicapped parking space in front of residence. Mr. Sacco was present and spoke behalf of request. After an onsite inspection of all Commissioners Member Duffy moved, seconded by Member Adams to recommend the following traffic rule to Council:

TRAFFIC RULE 4692: TO ESTABLISH A HANDICAPPED PARKING ZONE ON THE NORTH SIDE OF VERMONT STREET DIRECTLY IN FRONT OF 18 VERMONT STREET IN THE CITY OF WHEELING, AND EXTENDING ON VERMONT STREET FOR A DISTANCE OF 22 FEET

Request by Sharron Prout, 495 National Road, for handicapped parking space in front of residence. Ms. Prout was present and spoke behalf of request. After an onsite inspection of all Commissioners Member Duffy moved, seconded by Member Adams to recommend the following traffic rule to Council:

TRAFFIC RULE 4693: TO ESTABLISH A HANDICAPPED PARKING ZONE ON THE NORTH SIDE OF NATIONAL ROAD DIRECTLY IN FRONT OF 495 NATIONAL ROAD IN THE CITY OF WHEELING, AND EXTENDING ON VERMONT STREET FOR A DISTANCE OF 22 FEET

Request by Dottie Jaeger, 3510 Eoff St, for handicapped parking space in front of residence. Ms. Jaeger was present and spoke on behalf of request. After an onsite inspection of all Commissioners Member Adams moved, seconded by Member Duffy to recommend the following traffic rule to Council:

TRAFFIC RULE 4694: TO ESTABLISH A HANDICAPPED PARKING ZONE ON THE EAST SIDE OF EOFF STREET DIRECTLY IN FRONT OF 3510 EOFF STREET IN THE CITY OF WHEELING, AND EXTENDING ON VERMONT STREET FOR A DISTANCE OF 22 FEET

Request by Brandon Murry, 1213 McColloch St, for handicapped parking space in front of residence. Mr. Murry was present and spoke on behalf of request. After an onsite inspection of all Commissioners Member Adams moved, seconded by Member Duffy to recommend the following traffic rule to Council:

TRAFFIC RULE 4695: TO ESTABLISH A HANDICAPPED PARKING ZONE ON THE WEST SIDE OF MCCOLLOCH STREET DIRECTLY IN FRONT OF 1213 MCCOLLOCH STREET IN THE CITY OF WHEELING, AND EXTENDING ON VERMONT STREET FOR A DISTANCE OF 22 FEET

Request by Crystal Cork, 2300 Highland Ave, for no parking signs on Highland Ave. between Drop Street and N. 23 Street. Member Adams moved, seconded by Member Duffy to recommend the following traffic rule to Council:

TRAFFIC RULE 4696 TO ESTABLISH A NO PARKING ZONE, FIRE LANE, ON THE EAST AND WEST SIDE OF HIGHLAND AVENUE BEGINNING AT INTERSECTION OF DROP STREET AND HIGHLAND AVENUE, IN THE CITY OF WHEELING, AND EXTENDING IN A SOUTHERNLY DIRECTION ON HIGHLAND AVE TO THE INTERSECTION OF NORTH 23<sup>RD</sup> STREET

Request by Tim Birch for no parking on Custer Ave. Member Duffy moved, seconded by Member Adams to recommend the following traffic rule to Council

TRAFFIC RULE 4697 TO ESTABLISH A NO PARKING, FIRE LANE, ON THE SOUTH SIDE OF CUSTER AVENUE AND THE WEST SIDE OF BERSON AVE AND CUSTER AVE, IN THE CITY OF WHEELING, AND EXTENDING IN A WESTERLY DIRECTION ON CUSTER AVE AND NORTHERNLY DIRECTION ON BERSON AVE FOR A DISTANCE OF 50 FEET

Request by Dennis Russell, 2315 Jacob St, for handicapped parking space in front of residence. Mr. Russell was not present; however, commissioners had no objections. Member Duffy moved, seconded by Member Adams to recommend the following traffic rule to Council:

TRAFFIC RULE 4698: TO ESTABLISH A HANDICAPPED PARKING ZONE ON THE EAST SIDE OF JACOB STREET DIRECTLY IN FRONT OF 2315 JACOB STREET IN THE CITY OF WHEELING, AND EXTENDING ON JACOB STREET FOR A DISTANCE OF 22 FEET

There being no further business to come before the Commission, Member Duffy, seconded by Member Adams, to adjourn. Motion carried. Time: 2:38 PM.
